OSA - Club failed to prevent its spectators or players' parents from disrupting a game or for persisting in "using offensive, insulting or abusive language and/or gestures" directed at a Match Official(s) under the age of 18 or any other person. OSA - Discipline Hearing Administrative Fee Charged to Club. (if Accused (Player or Team official) is found guilty of Game Official Assault)	Club	\$200

<i>Late Payment – OSA Procedure - Any registrant failing to pay a fine, fee or bond imposed by a Discipline Hearing / Review Panel shall be subject to an additional monetary penalty and if still unpaid, shall be subject to suspension and shall remain under suspension until imposed penalty (plus the original fee, fine, bond) is paid. Time frame allowed to pay the fine is stipulated in the Decision Notice – 14 calendar days unless otherwise provided by the NSA.</i>	Player, Team Official, Administrator, Club or Match Official	As above
Fee example – Senior Player was found guilty of receiving their 3 <sup>rd</sup> Caution in the season and is suspended 1 game by DBR. NSA -DBR Fee of \$25 levied, with 14 days to pay. Player does not pay the DBR Fee within the 14 days and is fined Penalty for late payment of \$50 with 14 days to pay. Player now owes \$75. Player does not remit the \$75 within the second 14 day period (28 days from original suspension) and is now suspended from all soccer until both fees are paid.
