## All players receiving a red card INCLUDING THOSE RECEIVING a second caution

**DIRECTED AT A GAME OFFICIAL resulting in a red card will be required to attend a hearing.** However, the following are mandatory one game suspensions; intentional handball denying an obvious goal scoring opportunity, and persistent misconduct after a caution (yellow card).

In the case of a **second caution resulting in a red card (not directed at an official)** you have the option of coming for a hearing based on the above schedule. Or you can do the same as those with **accumulated yellow cards**; bring in the player book and payment to the NSA office by the end of business on the Wednesday following the offense and be assigned your game suspension(s) – see above schedule. For example - if your second caution was received up to July 17, 2017, you would be required to attend the NSA office with your book and the fine of \$25 by end-of-business Wednesday July 26, 2017.

The **player remains suspended until this is done**. Please be aware that late presentation of the PRB will result in a \$25 late fee. If the game(s) is cancelled, re-arranged or postponed then the suspension will carry forward until the re-scheduled date of the specific game, the player cannot sit out an alternate game.

Note: All Player Registration Books must be available on the required hearing date.
